With regard to **container detention**, our cut off for notification will be Wednesday 18 December at 1:00 pm. Notification can only be given for containers which are empty at that time. TCF has received communication from all transport operators that they will not be held responsible for any detention incurred where notification is after this period. Please note that during peak season periods collection of empties can take 72 hours or longer to arrange from notification to collect.
