Please note that due to the short weeks and subject to vessel availability advised by the Ports, delivery capabilities will be reduced. We will however endeavour to meet all delivery requirements during this period, please understand that there may be consequential delays particularly with the collection and de-hire of empty containers. Customs held entries will be monitored and advised clear status to the appointed carrier, which will be assessed & timeslot/s booked once the trucking company re-opens. If a hold is lifted over the Xmas/New Year closed period, wharf storage could be applicable pending on vessel availability at terminal/s.

Regarding **container detention**, our cut off for notification will be Friday 15 December at 1:00 pm. Notification can only be given for containers which are empty at that time. TCF has received communication from all transport operators that they will not be held responsible for any detention incurred where notification is after this period. Please note that during peak season periods collection of empties can take 72 hours or longer to arrange from notification to collect.
